

# IGFA ROYAL SLAM CLUBS

For purposes of the IGFA Royal Slam Clubs, a "Royal Slam" is defined as an individual angler catching, or catching and releasing, under IGFA rules the following species as listed below during his or her lifetime. Details on the eligible species for each Royal Slam Club can be found in the World Record Game Fishes book or online at <http://igfa.org/Fish/IGFA-Clubs.aspx>.

All catches, past and present are eligible as long as they have been caught in accordance with IGFA rules. It is not necessary to kill the fish, and the IGFA encourages catch and release. Photos of the angler with the fish and the contact information of the captain and/or witness are required for catches made after January 1, 2012.
